

CENTRAL CORRIDOR AREA Percentage Minority Population by Census Block, 2010









Size and Distribution of Elementary Students by Lunch Status for Schools with Attendence Areas within 1/4 mile of LRT Stations, 2012-2013





CENTRAL CORRIDOR AREA **Rental Costs for Market 2-Bedroom Unit by** Number of Units in Survey Locations, 2011


