The Volume IX Editors regret that, through no fault of the author's, two errors went uncorrected in the article by Congresswoman Eleanor Holmes Norton in the Symposium honoring Judge Higginbotham.

On page 392, in the first full paragraph, the sentence beginning "Remember" should have read as follows:

"Remember *what* the early sixties were for people. . . ."

In footnote 3, the second sentence should have read as follows:

"Although the riots for the most part were not deliberate protest strategies, they had a similar effect in pointing up serious problems in poor African-American communities."

The second error occurs on page 437 of Professor Brooks' article. The three paragraphs shown below should have been part of the block-and-indented quote:

But not all those who experience prejudice, discrimination or injustice feel comfortable making themselves the center of a highly publicized protest. Sometimes they find other ways.

One such quiet but significant act of protest involves one of the most esteemed black jurists in the nation, A. Leon Higginbotham, Jr., chief judge of the Third U.S. Circuit Court of Appeals in Philadelphia. It also involves one of the most esteemed institutions of legal scholarship, the University of Chicago Law School.

On February 20, 1990, Judge Higginbotham sent a letter to Dean Geoffrey Stone of the University of Chicago Law School. That letter reads in part as follows:
